
To reduce an entire year to a few paragraphs is obviously going to be rather subjective, but there are a few things that stand out in my mind:

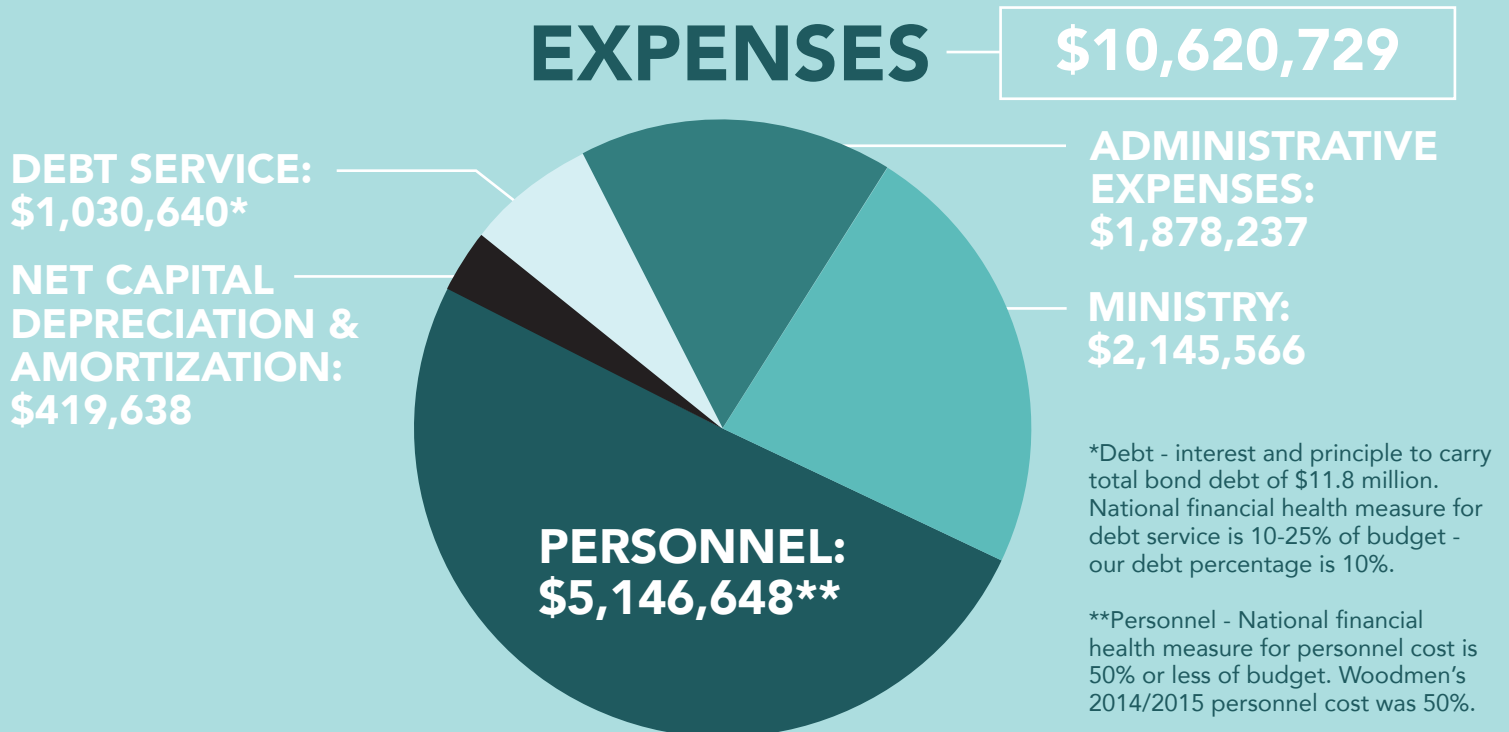
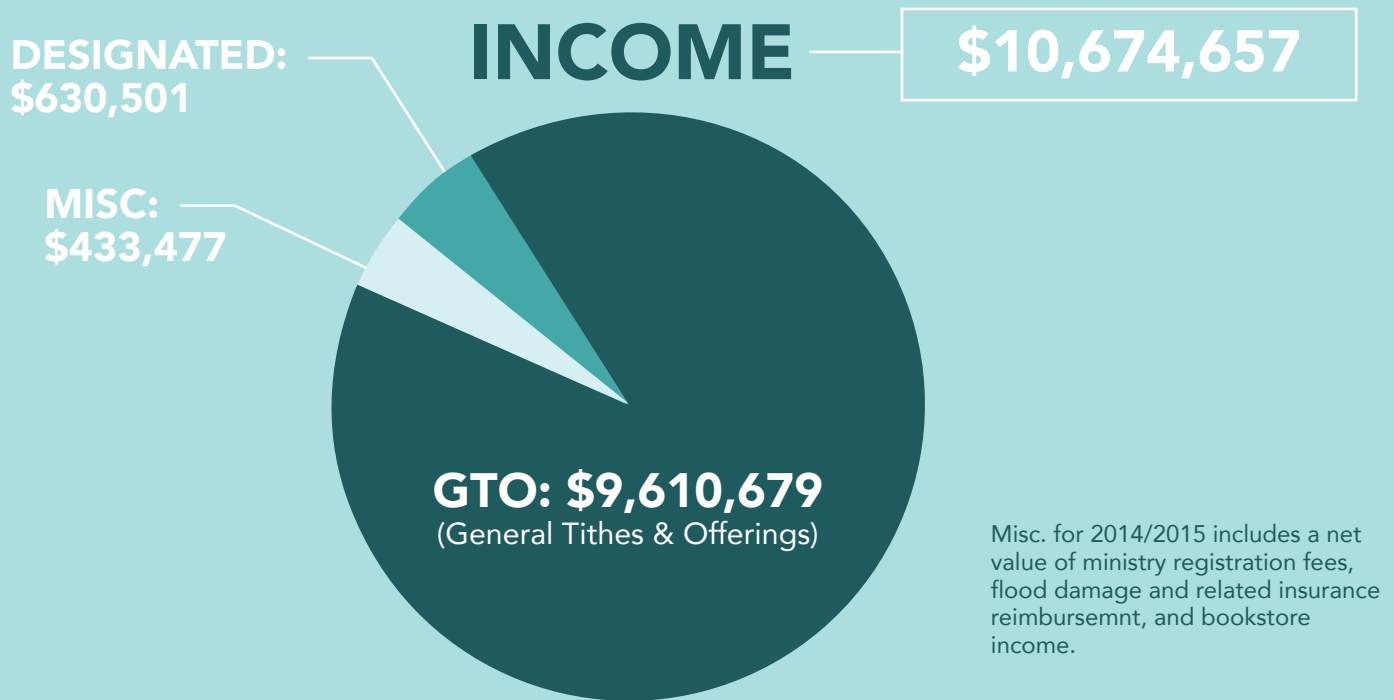

# FINANCIAL ACCOUNTABILITY

**Evangelical Council for Financial Accountability (ECFA):** WVC is a member of the ECFA, an organization that complies with all Generally Accepted Accounting Principles (GAAP), established standards for financial accountability, fund-raising and board governance, and a formal annual audit. Members include Christian ministries, denominations, churches, educational institutions and other tax exempt 501(c)(3) organizations. Collectively, these organizations represent more than \$18 billion in annual revenue. **Annual Audit:**

WVC completes a formal annual audit, conducted by one of the nation's leading not-for-profit auditing firms, to evaluate and certify all facets of our church business practices, financial policies, records, and reporting systems. The most recent annual audit received an exemplary report and evaluation, and is available upon request for public review. Each year's audit begins in November and upon conclusion is reported through the Finance Committee to the elders in December.

**Board and Fiduciary Responsibilities**

WVC's governance structure regarding fiduciary responsibilities is facilitated through three specific church entities. This governance structure is in compliance with and under the authority of Scripture, ultimately seeking God's direction in managing His resources.

**Elder Council:**

The Elder Council represents the approval authority in regard to all church business and financial matters. Although representing the final decision making body, the Elders delegate the review of church financial details and systems to the Finance Committee.

**Finance Committee:**

The Finance Committee is made up of church members who are specifically approved and appointed by the elders to be voting members of the committee for a three-year period. An active elder is the appointed moderator of the finance committee, which meets monthly to review extensive standard financial reports, and make financial recommendations to senior staff and the Elders. They are the central review board for budget matters, financial policies and church finances.

**Center for Strategic Ministry (CSM):**

Presently, the CSM facilitates the development of the Woodmen Heights campus, and manages the missions outreach of WVC. Reporting to the elders, the CSM Board of Directors serves as a fiduciary body with regard to budgetary issues in those two areas of endeavor. Board members include an Elder, who also serves as the liaison with other church governing bodies.

**West Side Community Center:**

Under an agreement with the City of Colorado Springs, Woodmen Valley Chapel has a management contract for the West Side Community Center. The Center has been created as a separate Limited Liability Corporation (LLC) under the governance of the CSM, a wholly owned subsidiary of Woodmen Valley Chapel.

**It is a Woodmen goal that fiduciary and stewardship governance for each budget year keeps our spending patterns at or below received income.**
