

## Church Generosity 6-Month Online Training

This free training comes from a generous grant that was given to the National Association of Evangelicals and your denomination. This committee-based online training is designed to be added to your agenda during your regular scheduled church leadership meetings over the next six months. Allow for up to 45 minutes in your meetings to go through this training experience together.

The course is built around 37 Best Practices that any church can consider doing. The average church is currently using anywhere from 10-15 Church Generosity [Best Practices](#), and most groups will likely decide on 8-15 Best Practices that could be a good fit for their church in the future. Every leadership team can customize their own action plans and calendar.

In addition to this Church Generosity online training, the Personal Finances online training course is available at no cost for anyone to complete in the privacy of their own home and on their own schedule. ### Step 1 - TRAIN

### Step 2 - DISCUSS

### Step 3 - PLAN

- Each leader should choose a [generosity devotional](#). You can get a free digital copy of the [40 Day Generous Life Devotional](#) and start going through with your spouse or family (5+ minutes per day). Go to your iPhone, Android or Windows phone or tablet app store and search for "givewithjoy" (one word, no spaces) or access a free online or email version at [GiveWithJoy.org](http://GiveWithJoy.org).
- The pastor and/or interested key church leaders should take the Church Generosity assessment survey at [NAEfinancialhealth.org/cgsurvey](http://NAEfinancialhealth.org/cgsurvey). Download and print out the [Church Generosity Best Practice worksheet](#), [planning calendar](#) and [online training course](#) and put them in a Financial Health folder or 3-ring binder.
