

Step 1 - TRAIN

Generous Life Devotional

A church-wide generosity devotional brings value to the families in your church:

- Bible-focused
- Family-friendly and group-friendly
- Multiple versions available (e.g., print, PDF and email)
- Easy to distribute or mail
- Companion resources and smart investment

Step 2 - DISCUSS & PLAN

Discuss when would be a good time for the Bless Your Pastor initiative at your church. If it will be completed at a different time than the Generous Life devotional, decide who will prepare the [letter](#) and/or email from your church leaders.

Bless Your Pastor Brochure and Appreciation Offering

“Bless Your Pastor” will not only bless your pastor, but the entire church:

- The [brochure](#) has over 50 creative ways people can bless their pastor year-round.
- Galatians 6:6 says, “Those who are taught the word of God should provide for their teachers, sharing all good things with them.” NLT
- 1 Corinthians 9:14 says, “...those who preach the Good News should be supported by those who benefit from it.” NLT
- The Bless Your Pastor appreciation offering, brochure and letter should be reviewed and organized by your church board or lay leaders.
